### **Environmental Policy Statement**

- Actively promote recycling both internally and amongst its customers and suppliers. We have recently partnered with the Volker Gruppe to help us dispose of our Polystyrene boxes in a sustainable way. They will collect and then process our EPS into compact briquettes that will be recycled for future use in building projects.
- Source a product range to minimise the environmental impact of both production and distribution.
- Meet or exceed all the environmental legislation that relates to the Company.

# **Energy Management Policy**

### **Waste Management Policy**

The company, by its normal business activities, generates waste. This may be broadly classified into three categories: liquid waste (effluent), solid product waste, and packaging and general waste.

### **Effluent waste:**

The company aims to reduce the generation of liquid waste and waste water to both reduce the negative impacts on the environment and reduce any associated costs.

The company employs the following actions to help you make appropriate reductions;

## 1. Saving water

Measures and monitors how much water you use.

Instructs staff to turn off water when not in use.

Maintains hoses and taps, and quickly fixes all leaks no matter how small.

### 2. Reducing effluent

Keeps waste and trimmings out of water wherever possible

Keeps waste off the floor, and

Doesn't let waste down the drain.

## **Solid waste:**

The Regulations control the collection, transport, storage, handling, processing and use or disposal of animal by-products. Of particular concern has been the ban on landfill of animal by-products both untreated and treated after 31 December 2005.

All solid waste is disposed of through licensed waste disposal contractors and is disposed of in an appropriate manner, with certification of disposal received for each batch

## **General and packaging waste:**

Where possible and practical the Company endeavours to collect all appropriate waste for re-cycling, separating materials and allocating them for collection by recognised recovery contractors.
